1. Owner agrees to pay the rate for pet care provided in effect on the date the pet is checked into Mountain View Pet Resort and agrees to pay all charges on the day of pick-up of the pet.

2. Owner further agrees that pet shall not leave the facility until all charges are paid.

3. Mountain View Pet Resort shall exercise reasonable care for the pet delivered by the Owner to the pet care provider. If interactive daycare is provided, Owner recognizes and accepts potential risks involved in such activity. It is expressly agreed by Owner and pet care provider that Mountain View Pet Resorts's liability shall in no event exceed the lesser of the current chattel value of a pet of the same species or the sum of \$400.00 per animal admitted. The Owner further agrees to be solely responsible for any and all acts of behavior of said pet while it is in the care of the pet care provider, to include payment of costs for injury to staff or other animals or damage to facilities caused by the pet.

4. Owner specifically represents that he or she is the sole owner of the pet, free and clear of all liens and encumbrances.

5. Owner understands that any animal left for ten days beyond the agreed day of pick-up may be sold or disposed of at the discretion of the kennel owner. The Owner specifically waives all statutory or legal rights to the contrary.

6. If pet becomes ill or injured, or if the state of the animal's health otherwise requires professional attention, Mountain View Pet Resort, in its sole discretion, may engage the services of a veterinarian or administer medicine to the animal and the expenses thereof shall be paid by the Owner.

7. To the best of the Owner's knowledge, the pet has not been exposed to rabies, distemper, or any contagious illness within a thirty-day period prior to check-in.

8. We acknowledge the inherent risk of exposure to contagious diseases/illnesses and do not hold Mountain View Pet Resort responsible should our pet become sick.

9. To the best of the Owner's knowledge, the pet has no illness or behavior problem (including aggressive or biting behavior) that has not been disclosed to us.

10. This agreement contains the entire agreement between the parties. All terms and conditions of this Agreement shall be binding on the heirs, administrators, personal representatives and assigns of the Owner and Mountain View Pet Resort.
